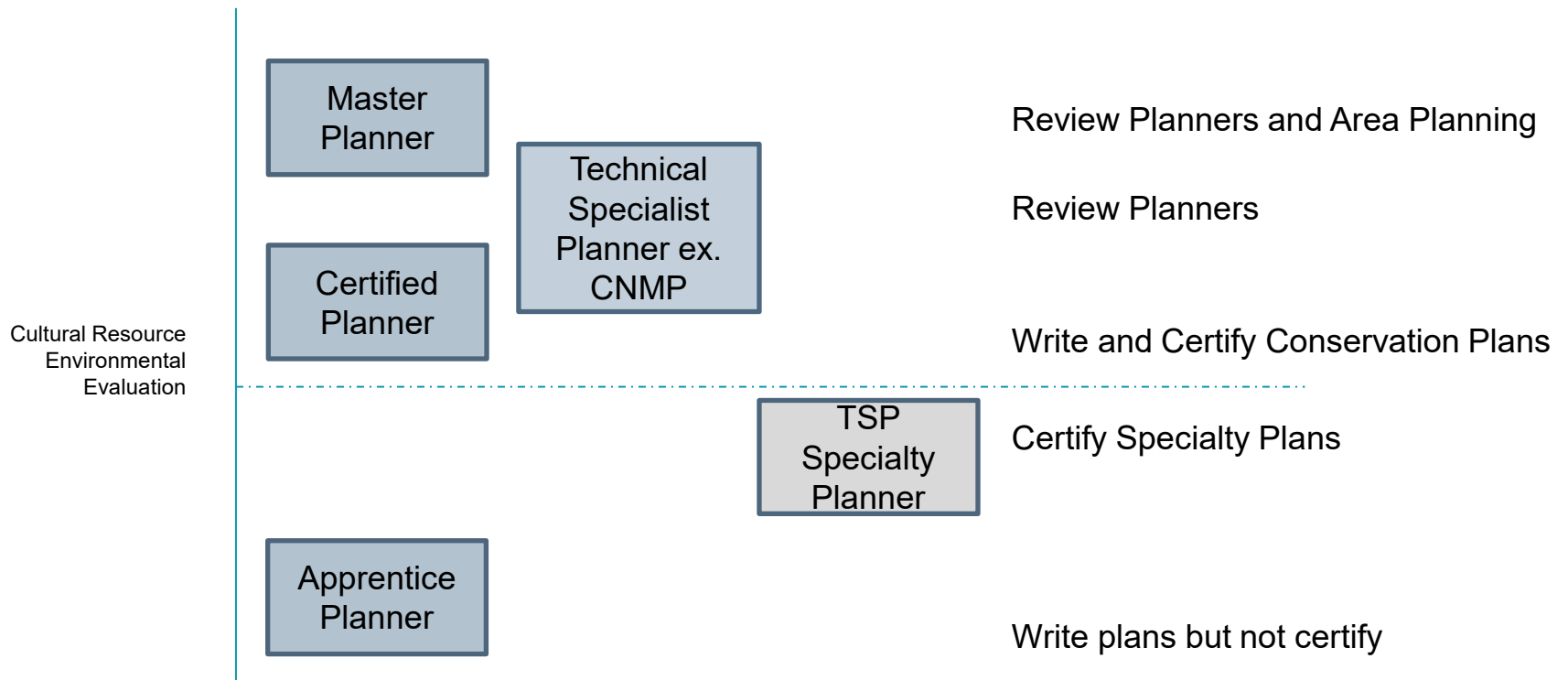
# What's in a Name

**We are changing the designations from:**

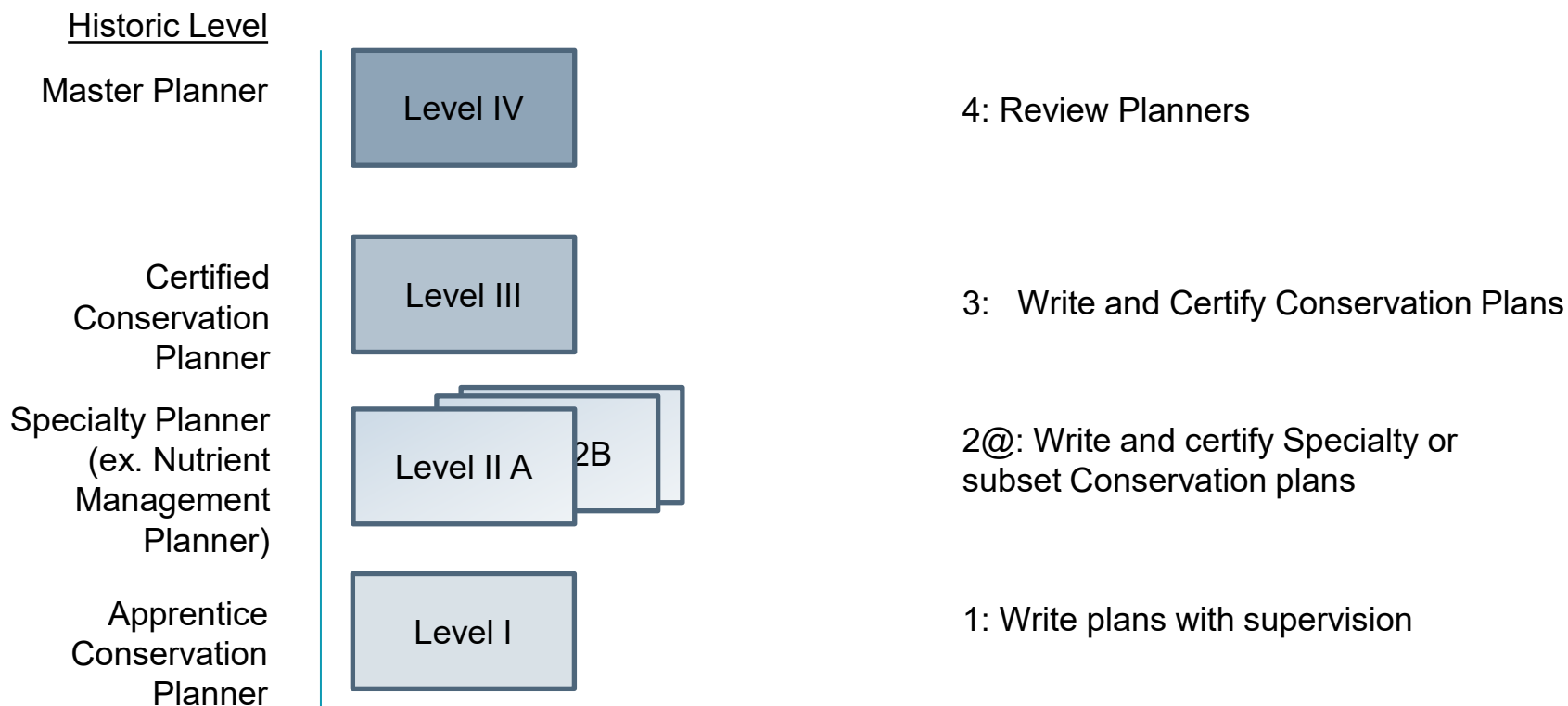
- **Apprentice Conservation Planner = Level I,**

# Job Approval Authority

- **The specific call out for Job Approval Authority (JAA) has been removed from the planner requirements.**
- **Supervisors will certify that the planner has an appropriate understanding of the practices and specifications.**
- **This may be measured by JAA and States can continue to utilize JAA for this purpose if they choose.**
